#### AGENDA ITEM SUMMARY/BACKGROUND

Chapter 30 of the Government Code requires that a Municipal Judge presiding over a Municipal Court of Record must be a resident of Texas, be a citizen of the United States, be a licensed attorney in good standing and have two or more years of experience in the practice of law in Texas. Additionally, the City Charter requires the judge and all associate judges be appointed by the Council for terms of two (2) years. The appointment for Council consideration is for a term beginning August 1, 2020 through July 31, 2022.

#### RECOMMENDATION

Staff recommends appointing Cynthia Burkett as the Associate Municipal Judge for the term beginning August 1, 2020 through July 31, 2022.

# AMENDMENT TO CONTRACT FOR SERVICES FOR ASSISTANT MUNICIPAL JUDGE

THIS CONTRACT is made and entered into this	day of,	2020,	by	and

to as "City". and CYNTHIA BURKETT. hereinafter i	eferred to as "Assistant (Associat	e) Judge".		

#### 1. APPOINTMENT OF ASSISTANT (ASSOCIATE) JUDGE

- a. The City of Corinth (hereinafter referred to as "City") does hereby APPOINT and contract for the services of CYNTHIA BURKETT (hereinafter referred to as "Assistant Judge" or "Judge") to service as an Assistant (Associate) municipal judge and magistrate for and under the laws of the State of Texas, for a TERM of two years, beginning on the 1<sup>st</sup> day of August, 2020, and continuing through midnight, July 31, 2022, with all powers, rights and duties of said appointment and as provided by the City Charter.
- b. The Assistant Judge shall comply with all requirements of law and must performs all duties as required by law and comply with all the terms of this contract, and conditions and restrictions as set forth for municipal judges under all applicable state statutes and as required under the Texas Code of Judicial Conduct.
- c. The Assistant Judge shall devote such time as necessary to perform the services set forth herein.
- d. The Assistant Judge may terminate this Contract by providing written notice of resignation not less than 30 days prior to date of termination.
- 2. <u>COMPENSATION OF ASSISTANT (ASSOCIATE) JUDGE</u> the City shall compensate the Assistant (Associate) Judge as follows:
  - a. As compensation for the Assistant (Associate) Judge's services, the City agrees to pay to the Judge according to this Section 2.
  - b. The Assistant (Associate) Judge shall receive a flat rate per duty performed according to the following schedule:
    - \$500 for full court day (morning & afternoon dockets)
       \$250 for half court day (morning or afternoon docket only)
       \*If docket is cancelled on day of court, the fee will be \$100.

\*If docket is cancelled before court day, no fee will be

ii. All other services:

\$75 per hour, with each duty being a minimum of one hour and any additional time for such duty which exceeds the first hour of time, will be billed in increments of one-half hour; including travel time to the Corinth Municipal Court to sign documents on non-court days, reviewing and executing Corinth Police Department documents, including, but not limited to, probable cause affidavits, arrest/search warrants, subpoenas, summons, blood search warrants, testimony in court relating to duties as a Corinth Judge or Magistrate.

iii. Judge/Court/Staff Meetings:

\$75 per meeting; attendance may include court staff, court administrator, or other invited City representatives, depending on issues to be discussed. Judge's meetings may be scheduled as needed and at the discretion of the Presiding Judge, Judge or the City, but it is anticipated that such meetings shall be held on a quarterly basis.

iv. Training Court Sessions:

\$400 for full day \$200 for half day

- c. The Assistant (Associate) Judge shall send an invoice to the City's Accounts Payable office by mail to 3300 Corinth Parkway, Corinth, TX 76208 or by email to accountspayable@cityofcorinth.com once per month not later than the fifth day of each month. The invoice shall indicate each date that the Judge performed a service outlined in Section 2b, above, a description of the service performed, and the applicable flat rate. The invoice shall also provide a total invoiced amount for the month.
- d. The City shall pay the Assistant (Associate) Judge once per month within 30 days from the date of the invoice is received by the City unless the invoice is disputed in good faith by the City, in which instance the City may withhold the amount(s) of the disputed charges until such dispute is settled.
- e. The Assistant (Associate) Judge must attend and complete any mandatory judicial education or other minimum judicial training as required by the State of Texas within the time periods as established by law. The City shall pay, or reimburse Assistant (Associate) Judge for, any mandatory judicial education and training, including specifically, all registration fees for such course, travel expenses, including flight, lodging and meal expenses on a pro rata basis based on the number of cities in which the Assistant (Associate) Judge serves. By way of example, if Assistant (Associate) Judge is a municipal judge or alternate judge in three municipalities (including Corinth), City shall pay for 1/3 of the above referenced expenses.
- f. The Assistant (Associate) Judge must maintain membership and licensure with the State Bar of Texas and pay all membership fees or dues on an annual basis as required by such membership or licensure. The Judge herein represents that such membership is in good standing and that all fees and mandatory continuing education requirements have been met at the time of this appointment and shall be maintained during the term of this Contract.

- g. During the duration of this Contract, the Assistant (Associate) Judge shall comply with all provisions of the Code of Judicial Conduct, the Corinth City Charter, Chapter 30 of the Texas Government Code, and all other applicable laws pertaining to the operations of the Corinth Municipal Court of Record, and duties as a Magistrate. In the event of a conflict between the terms of this Contract and said Code, Charter, Statutes and laws, the terms of said Code, Charter, Statutes and laws shall govern.
- h. The Assistant (Associate) Judge shall operate within the docket schedule prepared and coordinated by the Judge and Court Administrator. The Assistant (Associate) Judge shall timely perform all duties, including but not limited to, the dockets set forth in the docket schedule. No minimum amount of duties are guaranteed to the judge during the duration of this Contract.
- i. The Assistant (Associate) Judge shall comply with the Presiding Judge's "Standing Orders" which address the daily administration of the municipal court and trial procedures, for matters including but not limited to dismissals, installment payments, deferred disposition, and continuances. The City will provide the necessary Court Personnel to the Judge for clerical assistance.

#### 3. OUTSIDE LEGAL PRACTICE/JUDICIAL DUTIES; INDEPENDENT CONTRACTOR

- a. The City herein acknowledges that the Assistant (Associate) Judge may maintain a private law practice and may perform outside legal services. The Assistant (Associate) Judge shall not take on representation of a client if such representation would conflict with the Texas Code of Judicial Ethics or the Texas Rules of Professional Conduct. The Assistant (Associate) Judge shall not take on representation of a client adverse to the City of Corinth.
- b. The City further acknowledges that the Assistant (Associate) Judge may perform judicial or magisterial functions as a judge or magistrate for another city, county, or state agency, so long as the performance of such duties do not conflict with the duties of the office of municipal judge for the City of Corinth. The City therefore FINDS that the performance of such duties or holding of any other such office is of benefit to the state of Texas and there is no conflict with the duties of this office.
- c. The City may remove the Assistant (Associate) Judge from office during the Assistant (Associate) Judge's term of office pursuant to and in accordance with the requirements of §30.000085 of the Texas Government Code, or its successor, as same may hereafter be amended; or in the event the City's Charter is amended, in accordance with the provisions of the City Charter as amended.
- d. The Assistant (Associate) Judge shall be considered an independent contractor, not an employee of the City.
- e. The Assistant (Associate) Judge shall not represent a client in a case where an employee of the City, in his capacity as an employee of the City, is a witness or may be summoned to appear as a witness.

#### 4. DUTIES OF ASSISTANT (ASSOCIATE) JUDGES

- a. The Presiding Judge shall be the liaison between the Judge(s) and/or any City departmental staff. The Presiding Judge shall provide general supervision and guidance for Assistant (Associate) Judge.
- b. The Assistant (Associate) Judge shall perform duties assigned to the Assistant (Associate) Judges, from time to time, by the Presiding Judge in his sole discretion.
- c. The Assistant (Associate) Judge shall be available for any and all duties according to the monthly Judge's Schedule prepared by the Presiding Judge or when the Presiding Judge is unavailable, including after hours, weekends and holidays.
- d. The Assistant (Associate) Judge shall keep the Court and Corinth Police Department informed of his current contact information.

#### INTEGRATION

This Contract represents the entire and integrated Contract between the City and the Assistant (Associate) Judge, and supersedes all prior negotiations and representations and/or contracts either written or oral. This Contract may be amended only be written instrument signed by both the City and the Assistant (Associate) Judge. The Assistant (Associate) Judge further states that the Judge has carefully read the foregoing Contract, and understands the contents thereof, and signs the same as the Judge's own free act.

La cal un	is Contract, is made and entered into this15_ day of July, 2020 by and between American ndscape Systems, a corporation/partnership organized under the laws of the State of Texas, (hereinafter led the "Contractor") and the City of Corinth, Texas, a municipal corporation, organized and existing der laws of State of Texas, acting through its City Manager or other duly authorized designee, (hereinafter led the "City").
	r and in consideration of the covenants, performances, payments and agreements contained herein, and the mutual benefits to be obtained hereby, the parties agree as follows:
1.	TERM  This Contract shall commence beginning on the day of, 2020, and shall be in effect for a term of two (2) years, to expire at midnight, December 31, 2021, unless earlier terminated by either party in accordance with the terms of this Contract. This Contract may be renewed for three (3) additional one-year periods, if agreed upon in writing by both parties.
2.	SCOPE OF SERVICES  The Contractor agrees to provide all equipment, materials, supplies, labor, permits, insurance and licenses as necessary to perform

Any conflict in the foregoing documents shall be resolved by giving precedence first to this written Contract, and then to the Contract Documents in the sequential order listed above.

#### 3. PAYMENT

The City shall pay invoices for services properly performed within 30 days of receipt; provided however, that in the event the City requests any supporting documentation for charges, payment shall be made within 30 days of receipt of the documentation. The City's payment obligations are payable only and solely from funds available for the purposes of this Contract.

#### 4. CHANGES

The City may, from time to time, require changes in the scope of services of the Contractor to be performed hereunder. Such changes, which are mutually agreed upon by and between the City and the Contractor, become effective when incorporated in a written amendment to this Contract executed by both parties.

#### 5. TERMINATION OF CONTRACT

The City may terminate this Contract for any reason upon 10 days' notice to Contractor. Upon termination, the Contractor shall be entitled to payment of such amount as shall compensate Contractor for the services satisfactorily performed from the time of the last payment date to the termination date in accordance with this Contract, provided the Contractor shall have delivered to the City such statements, accounts, reports and other materials as required herein, and provided that Contractor shall have delivered to the City all reports, documents and other materials prepared by Contractor prior to termination. The City shall not be required to reimburse Contractor for any services performed or expenses incurred after the date of the termination notice.

#### 6. COMPLETENESS OF CONTRACT

This contract and any additional or supplementary document or documents incorporated herein by specific reference contain all the terms and conditions agreed upon by the parties hereto, and no other agreements, oral or otherwise, regarding the subject matter of this Contract or any part thereof shall have any validity or bind any of the parties hereto.

#### 7. INDEMNITY AND INSURANCE

- a) The Contractor hereby agrees to and shall indemnify, hold harmless, and defend the City, its officers, agents and employees from and against any and all claims, losses, damages, demands, causes of action, suits and liability of every kind, including all expenses of litigation, court costs and attorneys' fees, for injury to or death of any person, for loss of use or revenue, or for damage to any property arising out of or in connection with the actual or alleged malfunction, design or workmanship in the manufacture of equipment, the fulfillment of this Contract, or the breach of any express or implied warranties under this Contract. Such indemnity shall apply where the claims, losses, damages, causes of action, suits or liability arise in part from (i) the negligence of the Contractor, and/or their respective officers, agents and/or employees or (ii) the negligence of the Contractor, its officers, agents and employees. It is the expressed intention of the parties hereto, both Contractor and the City, that the indemnity provided for in this paragraph is indemnity by Contractor to indemnify and protect the City from the consequence of (I) the Contractor's own negligence where that negligence is the cause of the injury, death, or damage. Furthermore, the indemnity provided for in this paragraph shall have no application to any claim, loss, damage, cause of action, suit and liability where in injury, death or damage results from the negligence of the City. In the event any action or proceeding is brought against the City by reason of any of the above, the Contractor agrees and covenants to defend the action or proceeding by counsel acceptable to the City. The indemnity provided for herein shall survive the termination or expiration of this Contract.
- b) Contractor shall maintain and shall be caused to be in force at all times during the term of this Contract the insurance coverages required by the City's Invitation to Bid #1129.

c) This Contract is not intended to extend the liability of the parties beyond that provided by law. The City does not waive, limit, or surrender any immunity or defense available to the City.

#### 8. ASSIGNMENT

The parties hereby agree that Contractor may not assign, convey or transfer its interest, rights and duties in this Agreement without the prior written consent of the City.

#### 9. NOTICES


#### CALL TO ORDER:



**George Marshall, City Engineer,** gave a presentation outlining the details allowing golf carts on Corinth streets. He verified golf carts currently are permitted within the golf course community as long as they are going to or from the course. Mr. Marshall also confirmed the resident survey would include the prohibition of golf carts in bike lanes and sidewalks.

Receive a presentation from Staff regarding the possible opportunity to legalize the usage of golf carts on some public streets.

#### Legality of Driving Golf Carts on City Streets:

- Texas Transportation Code Chapter 541, 547, 548, 551, 601
  - So long as the City has not adopted an ordinance prohibiting it, a golf cart may be driven in a master planned community that meets certain conditions. No definition of a Master Planned Community.
  - Posted speed of 35mph or less
  - Package delivery special requirements.
  - Can be driven across an intersection of a public highway
  - Requires slow moving emblem, headlamps, tail lamps, reflectors, parking brake, mirrors
  - Requires liability insurance

#### Legality of Driving Golf Carts on City Streets:

- TxDMV Definition of a "golf cart" has no less than 3 wheels, max speed 15-25 mph, manufactured primarily for operation on golf courses.
- All "self-propelled" vehicles must follow the rules of the road, except when state law provides otherwise.
- Must a driver be licensed? Depends on who you ask. Not specific in the code but at least 1 DPS rep. has been quoted as stating it is required.
- A neighborhood electric vehicle (NEV) is not the same as a golf cart. NEV must have headlamps, stop & turn signal lamps, reflectors, parking brake, certain mirrors, a windshield, seat
- An off-highway vehicle (OHV) is also not the same as a golf cart. For use, or utility use, has a triangular flag 6' high, headlamps, tail lamps, driver's license, daytime use, distance less than 25 miles beginning to end.



#### Lake Cities' Desire for Golf Cart Regulations

- Established reciprocal ordinances to allow golf carts to travel within their cities.
  - -Lake Dallas
  - -Hickory Creek



#### **Ordinance Requirements**

- May operate on streets posted 35 mph or less.
- Permit Required (2-year period)
  - -Reciprocity (1 permit for use in both Cities)
- Must have a driver license
- Insurance
- Exception applied to City Employees while acting within the course and scope of their job





#### Requirements

- Driver and passengers must remain seated and wear seatbelt
  - May not stand or ride on the lap of driver or other passenger
- May not operate the vehicle on any portion of Swisher except to cross at N. Shady Shores Road

#### Requirements

- May not operate in park, sidewalk, path, or park trail
- Must move cart to the right and yield the right-of-way to faster moving vehicles
- May cross multi-lane federal, state, or county roads only at an intersection with traffic control for all directions

3. Provide an update, hold a discussion and receive direction on the Coronavirus (COVID-19) in regard to City operations and practices.

City Manager Hart discussed the proposed plan of moving forward with Yellow status for COVID-19. The outline included the total number of cases, Corinth's response plan, the relief fund/expenditures, and budget estimates. Regarding the budget summary, Mr. Hart clarified the payroll expenditures only include paramedics, not captains, or administrative support and also explained the extractor, which is a piece of equipment to sanitize the fire department's gear.

Lee Ann Bunselmeyer, Finance, Administration, Communications & Marketing Director shared with Council the increase in non-payment of utility accounts, stating that there have been no requests for accommodations due to COVID-19.

City Manager Hart and Lee Ann Bunselmeyer, Finance, Administration, Communications & Marketing Director spoke with the Council regarding the budget, stating the city is down from approximately a half million from the original million previously discussed. The savings came from salary savings, cancellation of summer camp, special events, and training.

George Marshall, City Engineer, responded to a question from Council regarding the Safe Routes to School Grant stating the city did not pursue the grant was due to COVID-19 and financials, as they were not confident they could dedicate the funds to the project.

City Manager Hart verified with the Council their comfortable with continuing Yellow status until August 3<sup>rd</sup>, returning to the standard, existing policy for water disconnects for non-payment and the county funding, treating as a budget approach.




# **Setting Speed Limits**

- Texas Transportation Code Sec. § 545.356 Authority of Municipality to Alter Speed Limits
  - alter by ordinance prima facie speed limits from the results of an <u>engineering and traffic</u> investigation
  - the governing body of a municipality, for a highway... that is not a ... road of the state highway system, may declare a lower speed limit of not less than 25 miles per hour, if ...determines... speed limit... is unreasonable or unsafe
    - applies only to a two-lane, undivided highway
    - municipality that declares a lower speed limit... shall publish on its Internet website and submit to the department a report that compares for each of the two previous calendar years:
      - (1) the number of traffic citations issued by peace officers of the municipality and the alleged speed of the vehicles, for speed limit violations on the highway or part of the highway;
      - (2) the number of warning citations issued by peace officers of the municipality on the highway or part
        of the highway; and
      - (3) the number of vehicular accidents that resulted in injury or death and were attributable to speed limit violations on the highway or part of the highway.



In general, signs are often ineffective in modifying driver behavior, and overuse of signs breeds disrespect and diminishes effectiveness. Unnecessary signs and posts represent a hazard to errant motorists and may cause an obstruction to pedestrians and bicyclists. Furthermore, unnecessary signs are a waste of taxpayer dollars, represent an ongoing maintenance cost, and are a source of visual blight


# Summary

- Reduce speed limits in residential neighborhoods from 30 mph to 25.
  - Effective as soon as speed limit signs are installed
  - Remove "Children Playing" Signs. (good place for a 25mph sign to be installed)

## WATER/WASTEWATER RATE STABILIZATION FUND

- In 2019, a Rate Stabilization Fund was established to assist in offsetting temporary increases to the budget and increases from the Upper Trinity Regional Water District (UTRWD) and City of Denton. Use of the funds will require authorization from the City Council.
- Savings each year from the utility fund expenditure budget and revenue collections that exceed the budgeted amount for water and wastewater charges will be utilized as a means of funding the reserve.
- The fund shall strive to maintain a balance not to exceed 15% of the Utilities expenditure budget.




Fund Balance of \$250,000



## WHAT IS SEWER AVERAGING?



Each year, residential monthly water consumption is measured and averaged to establish the monthly sewer charge for each customer for the upcoming year.

The sewer averaging process consists of usage during the months of November, December, January, and February.

By conserving water during this period residents can control their monthly sewer charge.

The winter month with the highest consumption is discarded and the remaining three months' consumption are averaged together to reflect the resident's average consumption.

Each resident's sewer charge is based on their own average consumption that is determined during Sewer Averaging. The bills that are due in April will reflect the new sewer charge which will be in effect for the next twelve months.

## Benefits of Sewer Averaging

Sewer Charges Remain Consistent each month

Allows customers opportunity to lower their **sewer** bill by reducing water use during winter months.



# **Budget Billing**

- Provides a more level monthly bill amount that would occur with normal seasonal variations in services.
- ✓ Each month the system adjusts the actual bill to equal the average bill amount.
- ✓ Two Options
  - Fixed Average System sets a fixed amount.
    - ✓ There is a settle-up month every six months to a year and the average bill is recalculated for the next term.
    - ✓ There can be a disparity between the actual usage in a period and how much is billed.
  - Running Average Charges a bill based on running 12-month average.
    - ✓ Designed to be self-adjusting as seasons, usage and rates change.
    - Reduces the amount owed or due at the time of Settlement. Can set the settlement at six months to a year.

### No-New-Revenue Maintenance & Operations (M&O) Rate

Enables the public to evaluate the relationship between the Maintenance & Operations taxes for the prior year and for the current year, based on a tax rate that would produce the same amount of taxes if applied to the same properties taxed in both Years.

#### Calculating the M&O Portion of the Voter-Approval Tax Rate

Last Year's Levy - Last Year's Debt ÷ Current Total Value - New Property Value = Maintenance and Operations Rate

### De Minimis Rate

The De Minimis Rate is a new tax rate calculation designed to give smaller taxing unit, cities with a population of less than 30,000, some relief from the 3.5% voter approval rate.

De Minimis Rate is equal to the sum of :

- · A taxing units no-new-revenue M&O rate
- The rate that when applied to a taxing current total value, will impose an amount of taxes equal to \$500,000; and
- · A taxing unit's current debt rate

### **Unused Increment Rate**

The unused increment rate can be used to increase the voterapproval tax rate.

It is a three-year rolling sum of the difference between the actual tax rate and the voter-approval tax rate.

A City has the ability to "bank" any unused amounts below the voter-approval tax rate to use up to three years.



The unused increment rate is zero for 2020 and will not be available until 2021.

### **Debt Rate**

A taxing unit that levies a debt service rate must consider anticipated collections in calculating the debt service component of its Voter Approval Tax Rate.

The collector for a Taxing Unit must certify the current year's certified anticipated debt collection rate and last year's excess debt tax collections to the governing body.

Adjustments to the current year's debt service rate <u>include excess collections from the previous year</u> and the anticipated collection rate for the current year.

### Notice of Public Hearings on Tax Increases

The required notice may be published in a newspaper or by mailing it to each property owner in the city. If published in newspaper, it must also be placed on the homepage of the taxing unit's website.

#### Newspaper:

- · The notice cannot be part of the paper in which the legal notices and classified advertisements appear.
- The notice must be at least a quarter-page in a standard size or tabloid size newspaper with a headline in 24-point type or larger.

#### Website:

- · Notice must be posted on the city website, if notice is published in the newspaper.
- Must be post notice of the public hearing prominently on the homepage continuously at least seven days before the public hearing on the proposed tax rate,
- Must be posted at least seven days immediately before the date of the vote proposing the increase in the tax rate.
- It must remain on the taxing unit's website until the public hearing is concluded.

**City Manager Hart** delivered the COVID-19 presentation to the Council and also noted Governor Abbott issued an executive order today, mandating the wearing of masks. The presentation included CDC recommendations and resident survey results. Mr. Hart stated by adopting the ordinance, it would allow the city to assist the businesses to obtain the signs for their business.

**City Attorney Adams** clarified the reason for Corinth adopting the ordinance is to fill the gap of the governor's order. GA-29 allows for cities to impose a penalty for businesses or individuals.

### Centers for Disease Control

Recommendations for healthy individuals

- Practicing hand hygiene and respiratory etiquette regularly
- Maintaining physical distance when around others
- Utilizing masks or face coverings when around others
- Staying home if you are sick or have recently had close contact to a person with COVID-19



Centers for Disease Control Effectiveness of Cloth Face Coverings



- O Cloth face coverings are recommended as a simple barrier to help prevent respiratory droplets from traveling into the air and onto other people when the person wearing the cloth face covering coughs, sneezes, talks, or raises their voice. This is called source control.
- This recommendation is based on what CDC knows about the role respiratory droplets play in the spread of the virus that causes COVID-19, paired with emerging evidence from clinical and laboratory studies that shows cloth face coverings reduce the spray of droplets when worn over the nose and mouth.
- O COVID-19 spreads mainly among people who are in close contact with one another (within about 6 feet), so the use of cloth face coverings is particularly important in settings where people are close to each other or where social distancing is difficult to maintain.

### Who Should Wear a Cloth Face Covering?

- CDC recommends all people 2 years of age and older wear a cloth face covering in public settings when around people outside of their household



### Feasibility and Adaptions

CDC recognizes that wearing cloth tace coverings may not be possible in every situation or for some people. In some situations, wearing a cloth face covering may exacerbate a physical or mental health condition, lead to a medical emergency, or introduce significant safety concerns. Adaptations and alternatives should be considered whenever possible to increase the feasibility of wearing a cloth face covering or to reduce the risk of COVID-19 spreading if it is not possible to wear one.

- Individuals who are deaf or hard of hearing or those who care for or interact with a person who is hearing impaired.
- O Individuals with developmental disabilities, sensory integration concerns or tactile sensitivities, certain mental health conditions, or limited cognitive ability may have a negative reaction to wearing a cloth face covering.
- O Younger children (e.g., preschool or early elementary aged) may be unable to wear a cloth face covering properly, particularly for an extended period of time. Wearing of cloth face coverings may be prioritized at times when it is difficult to maintain a distance of 6 feet from others.
- O Individuals should not wear cloth face coverings while engaged in activities that may cause the cloth face covering to become wet, like when swimming or at the beach.
- Individuals who are engaged in high intensity activities, like running, may not be able to wear a cloth face covering if it causes difficulty breathing.
- Individuals who work in a setting where cloth face coverings may increase the risk of heat related illness or cause safety concerns due to introduction of a hazard (for instance, straps getting caught in machinery)




### Safety Measures Survey Published June 28 – July 1


# Survey Participants Which of the following best describes you?






# Survey Participants In which decade where you born?






# Survey Participants Where do you live?






# Do you currently wear a mask when going out in public?






Should the City institute a mask requirement for all customers in businesses in the City of Corinth until COVID-19 statistics indicate the near end of the pandemic locally?






Should the City institute social distancing requirement for all customers in businesses in the City of Corinth until COVID-19 statistics indicate the near end of the pandemic locally?





















### Comments For

As a small business owner that brings tax dollars into the city of Corinth I will do what ever is needed for the community, EXCEPT closing my business. I can not close down again. I need to feed my family. If necessary to keep my business open I will wear a mask and have my customers do so. I am a believer in herd immunity and feel that requiring people to stay home will only slow down the virus and keep this going for months with no end in sight. Immunity needs to be built! Elderly and high risk should be able to understand their need to stay home and take more precautions. Those of us who are not near elderly or have high risks should not have to submit to stay at home requirements.

The individuals that yell I will not wear a mask you will not take away my rights, have only concerns for themselves and no concern for individuals around them who may be compromised and able to contract the disease more easily. I think masks are easy and smart and accessible and a great way to slow the spread of the virus.

Covid -25 Texas - 0. Texas is loosing this! Please be proactive and require masks. Please be proactive instead of reactive. 

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CORINTH, TEXAS, REPEALING ORDINANCE NO. 20-02-13-04 ORDERING AND CALLING A SPECIAL ELECTION FOR THE CITY OF CORINTH. TEXAS TO BE HELD ON SATURDAY, MAY 2, 2020 AND ORDINANCE NO. 20-04-02-09 POSTPONING SUCH SPECIAL ELECTION TO TUESDAY. NOVEMBER 3, 2020 FOR THE PURPOSE OF SUBMITTING TO THE QUALIFIED VOTERS OF THE CITY. A BALLOT PROPOSITION ON THE QUESTION OF APPROVING AND IMPLEMENTING RESOLUTION NO. 20-02-06-08, DESIGNATING A MULTIPURPOSE AMPHITHEATER AND RELATED INFRASTRUCTURE AS A SPORTS AND COMMUNITY VENUE PROJECT, ("AMPHITHEATER VENUE PROJECT"), AND ADOPTING A NEW TAX, A SHORT TERM MOTOR VEHICLE RENTAL TAX AT A MAXIMUM RATE OF FIVE PERCENT (5%), TO FUND THE AMPHITHEATER VENUE PROJECT: PROVIDING **FOR** INCORPORATION OF PREMISES; REPEALING ORDINANCE NO. 20-02-13-04 AND ORDINANCE NO 20-04-02-09 AND CANCELING THE SPECIAL ELECTION: PROVIDING A CUMULATIVE REPEALER CLAUSE: PROVIDING A SEVERABILITY CLAUSE: AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, on or about February 13, 2020, the City adopted Ordinance No. 20-02-13-04, which, in part, ordered a joint special election for the purpose of submitting to the qualified voters of the City, a ballot proposition on the question of approving and implementing Resolution No. 20-02-06-08, designating the Amphitheater Venue Project as a sports and community venue project, and adopting a new tax, a short term motor vehicle rental tax at a maximum rate of five percent (5%), to fund the Amphitheater Venue Project, for Saturday, May 2, 2020; and

**WHEREAS**, on or about March 13, 2020, the Governor of the State of Texas certified that the novel coronavirus (COVID-19) poses an imminent threat of disaster and, under the authority vested in the Governor by Section 418.014 of the Texas Government Code, declared a state of disaster in every county in the State of Texas; and

**WHEREAS**, on or about March 18, 2020, the Governor issued a Proclamation suspending certain sections of the Texas Election Code, among others, to allow political subdivisions of the State that would otherwise hold elections on May 2, 2020, to postpone general and special elections for 2020 only to the next uniform election date, November 3, 2020 without otherwise adjusting the election date; and

**WHEREAS**, it is pursuant to the authority of the Governor's March 13, 2020, disaster declaration and the March 18, 2020 Proclamation that Ordinance No. 20-04-02-09 was adopted to postpone the joint special election from Saturday, May 2, 2020, to Tuesday, November 3, 2020; and

**WHEREAS**, the Council no longer desires to hold the special election pursuant to Ordinance No. 20-02-13-04 and Ordinance No. 20-04-02-09 and wishes to cancel such special election.

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CORINTH, TEXAS:

#### SECTION 1 INCORPORATION OF PREMISES

All of the above findings are hereby found to be true and correct and are hereby incorporated into the body of this Ordinance as if fully set forth herein.

# SECTION 2 ORDINANCES CALLING AND POSTPONING ELECTION REPEALED AND CANCELLATION OF SPECIAL ELECTION

Ordinance No. 20-02-13-04 and Ordinance No. 20-04-02-09 are hereby repealed in their entirety and the special election scheduled for Tuesday, November 3, 2020, for the purpose of submitting to the qualified voters of the City, a ballot proposition on the question of approving and implementing Resolution No. 20-02-06-08, designating the Amphitheater Venue Project as a sports and community venue project, and adopting a new tax, a short term motor vehicle rental tax at a maximum rate of five percent (5%), to fund the Amphitheater Venue Project, is hereby cancelled.

# SECTION 3 POSTING

The City Secretary is directed to cause a copy of this ordinance to be posted on election day at each polling place used or that would have been used in the election.

# SECTION 4 CUMULATIVE CLAUSE

This Ordinance shall be cumulative of all provisions of Ordinances of the City of Corinth, Texas, except where the provisions of this Ordinance are in direct conflict with the provisions of such ordinances, in which event the conflicting provisions of such ordinances are hereby repealed.

# SECTION 5 SEVERABILITY CLAUSE

It is hereby declared to be the intent of the City Council of the City of Corinth that the phrases, clauses, sentences, paragraphs, and sections of this Ordinance are severable, and if any phrase, clause, sentence, paragraph, or section of this Ordinance shall be declared unconstitutional by the valid judgment or decree of any court of

competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs, or sections of this Ordinance, since the same would have been enacted by the City Council without incorporation of any such unconstitutional phrase, clause, sentence, paragraph, or section.

#### SECTION 6 EFFECTIVE DATE

This Ordinance shall become effective from and after its passage.
